<b>Hazardous ingredients</b>

<b>4. FIRST AID MEASURES</b>	
Skin Contact	If the molten material gets on skin, quickly cool in water. Seek immediate medical attention. Do not try to peel the solidified material from the skin or use solvents or thinners to dissolve it.

<b>5. FIRE-FIGHTING MEASURES</b>	
Suitable extinguishing media	Water. Water mist. Dry chemical. Carbon dioxide (CO <sub>2</sub> ). Foam. If possible, water should be applied as a spray from a fogging nozzle since this is a surface burning material. The application of high velocity water will spread the burning surface layer. To minimize this hazard, bonding and grounding may be necessary, but may not by themselves be sufficient.</p> <p>Avoid creating dust.</p> <p><b>Storage</b> Keep in a dry place.
